- When risks cannot be eliminated, special work processes, safety devices, personal protective equipment or other measures must be used to safeguard employees and third parties

## Security Policy

SEACOR Marine ensures that all vessels are operated under a company approved security plan with procedures designed to protect people, property and the environment against all known forms of security threats. The known security threats can range from piracy, hijacking, seizure of persons or property, tampering with cargo, equipment or stores, stowaways, smuggling of dangerous substances or devices, armed robbery, theft, unauthorized boarders or cyber security. These security plans are approved by Flag State and/or Class under the International Code for the Security of Ships and Port Facilities Part A (ISPS Code).

SEACOR Marine strives to minimize our impact to the environment. As a marine services company, we recognize the importance of meeting our responsibility to operate in an environmentally sound manner while protecting the health and safety of our employees and the public.
